

Resolution to Accept Jurisdiction and Maintenance
of the Village of Whiteash Roads

County Resolution No. 15-01-05-01

Providing for the transfer and acceptance of roads from the Village of Whiteash, in Williamson County, Illinois to the County of Williamson, in Illinois. These roads shall be added to the County Unit Road District system of roadways in the County of Williamson, Illinois.

Whereas, the County Board of Williamson County and the Village of Whiteash will enter into an agreement for the transfer and acceptance of the jurisdiction and maintenance of all existing public roads within the Village of Whiteash to the County of Williamson.


Now, therefore, be it resolved, that all the existing public roads shown on the attached map/listing within the Village of Whiteash be transferred and accepted by the County of Williamson.

Be it further resolved, that the clerk is hereby directed to transmit three certified copies of the Resolution to the Illinois Department of Transportation through its Regional Office located in Carbondale, Illinois.

**PUBLIC ROADWAY
MAINTENANCE & JURISDICTIONAL
TRANSFER AGREEMENT**

This agreement, entered into this 5th day of January, 2015, by and between the COUNTY OF WILLIAMSON, in the State of Illinois, hereinafter called the COUNTY, and the VILLAGE OF WHITEASH, in the State of Illinois, hereinafter called the VILLAGE respectively.

WITNESSETH

Now, therefore, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

I. THE VILLAGE AGREES:

1. To transfer the jurisdiction and maintenance of, upon execution of this AGREEMENT, the existing public roadways currently under the jurisdiction of and maintained by the VILLAGE as shown in Attachment A-1 and A-2. These public roadways shall be removed from the municipal street system of the VILLAGE.

II. THE COUNTY AGREES:

1. To accept jurisdiction and maintenance of, upon execution of this AGREEMENT, the existing public roadways currently under the jurisdiction of and maintained by the VILLAGE as shown in Attachment A-1 and A-2. These public roadways shall be added to the County Unit Road District system of roadways in the COUNTY.

III. IT IS MUTUALLY AGREED:

1. This AGREEMENT shall be binding upon execution and apply to both parties, their successors, and assigns.
2. Maintain for a minimum of three (3) years after the execution of this agreement any books, records and supporting documents to verify the amounts, recipients and uses of all disbursements of funds passing in conjunction with the VILLAGE's dissolution. All books, records and supporting documents shall be available for review and audit by the Auditor General or other State of Illinois auditors; and the VILLAGE agrees to cooperate fully with any audit conducted by the Auditor General or other State of Illinois auditors and to provide full access to all relevant materials.

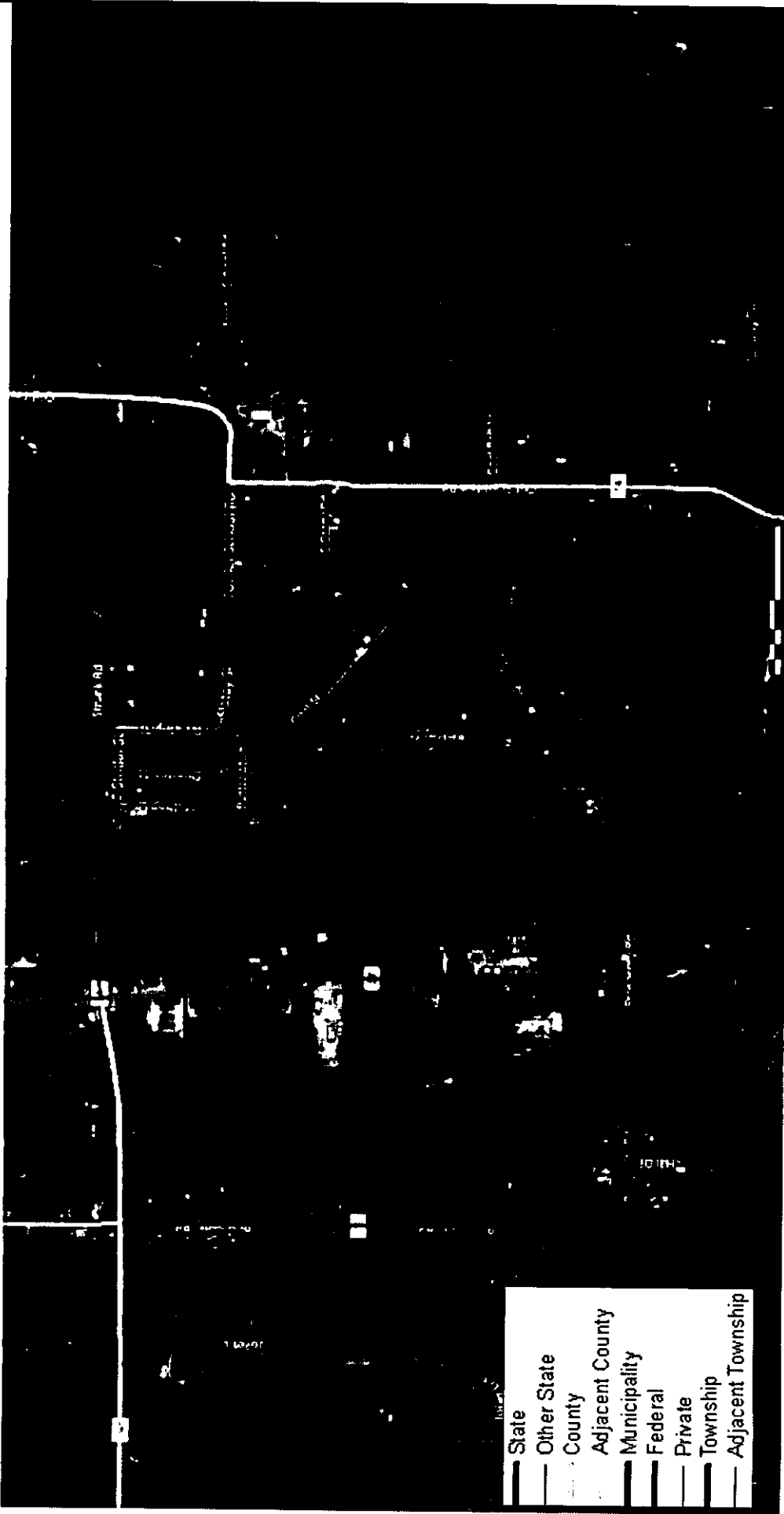
