Carrie brought along maps for the Commissioners to mark what they would like included in the expansion. A meeting at a later date will be set up to go over this information with Carrie.

Discussion was had on Human Resources position. With the new vacancy, the question was brought up if the HR position was to remain under the County Clerk or if it would go to Commissioners. The Commissioners have talked about it in the past to bring the position under them. Tabled
